WILLIAM H. SOULE Jailer and Deputy Sheriff Tombstone, AZ by Karen L. McNally

In celebration of Soule Kindred's 45th anniversary year, articles from past newsletters will be reprinted throughout the year. This letter appeared in Vol. VI, No. 3 (July 1972) in a section of the newsletter titled **Historical Gleanings**. The Editor at that time was Soule Kindred Co-Founder, George Standish Soule.

ear Mr. Soule,

You may already have these bits of information, but if you haven't, you might find them interesting. At any rate, someone might find these facts useful.

The United States census for 1880, city of Tombstone, county of Pima, Arizona, E. D. 2, page 7, Allen Street, Family #165, lists Virgil W. Earp and his wife Allie, Wyatt S. Earp and his wife Mattie, and James C. Earp and his wife Bessie and daughter Hattie.

A few doors away, Allen Street, Family #169, is listed William H. Soule, age 36, farmer, born in Massachusetts. His father was born in Maine, his mother in Ireland. He was the sole member of his family.

Months later came the big shootout at O.K. Corral, involving the Earps, Doc Holliday, the Clantons, and the McLowreys. At the hearing held later, William Soule, jailer and deputy sheriff, testified. A copy of his testimony from the book "The Earp Brothers of Tombstone" is enclosed.

Offhand, I would assume this William H. Soule was a descendant of either Barnabas or Jedediah Soule of Freeport, ME.; but who knows? It would be interesting indeed to find out who he was, and whatever became of him.

I am not a Soule descendant but my wife is, and I am the genealogist of the family. Her descent is as follows: Ellen Jane¹² Rogers, Harry Joel¹¹ Rogers, Lenora¹⁰ Brandt, Charlotte⁹ Hamilton, Eben H.⁸ Hamilton, Charles⁷ Hamilton, Ambrose⁶ Hamilton, Deborah⁵ Soule, Jedediah⁴ Soule, Moses³ Soule, John² Soule, George¹ Soule (Mayflower Pilgrim).

The following excerpt from The Earp Brothers of Tombstone (p.168) was sent by Mr. Ross:

"Well, the shootin' had come," related Allie, "and the city fathers had fired Virge as marshal right off. He was mad and his feelin's was hurt. Now was the time for us to get out of Tombstone. But of course I knew we couldn't. Morg was still sufferin' with his shoulder, and Virge couldn't get out of bed with his leg. They kept me and Lou busy. We hardly never left the house, and kept waitin' to hear how Wyatt and Doc Holliday was makin' out at the courthouse. I still kept Morg's six-shooter handy, just in case. It was a bad time for all of us. The weeks kept draggin' on."

The hearing occupied the full month of November, and the examination of witnesses consumed twenty-two full days.

James Kehoe, a butcher, testified that "Frank McLowery was not armed when at my shop (just before the fight)."

Andy Mehan, in the saloon business, swore that Tom McLowery left his pistol with him between one and two o'clock on the day of the fight. "I still have it."

William Soule, jailer and deputy sheriff, swore that the rifles were in their scabbards on Frank McLowery's and Billy Clanton's horses "when I took them to Dunbar's livery stable."

J. H. Allman, saloonkeeper, testified that the rifles and pistols belonging to Ike Clanton were behind his bar before and after the shooting, and that the first two shots were fired by Holliday and Morgan Earp.

A Bauer, a butcher who was accused by the Earps of being in league with the rustlers and selling their stolen beef, swore, "I had no dealing with the McLowerys or Clantons as long as I was in the butcher business."

B H. Fallahy testified that he heard Behan's and Virgil Earp's conversation just before the fight and that Virgil said, "Those men have made their threats; I will not arrest them but kill them on sight."

Mrs. M. J. King, whom they passed on the way to the O.K. Corral, testified that one of the Earps said, "Let them have it," and that Doc Holliday answered, "All right."

A Soule involved with the Earps and the O.K. Corral? Now, that is too much of a temptation to pass up. And I know all of you genealogists and historians out there know what I mean!

A bit of online sleuthing revealed some insight into William H. Soule's life from 1880 forward. As you'll read below, the shooting at the O.K. Corral was not the only exciting incident in which he was involved.

1880^{A1} - A William H. Soule (age 36, born in MA) does, indeed, live down the street from Virgil, Wyatt, and James Earp and their wives in Tombstone, AZ. Virgil and Wyatt are farmers, as is William, and James is a saloon keeper.

10/24/1881^{B1} - Three prisoners break out of the county jail in broad daylight. Jailer Soule is gone and the remaining jailer is overpowered by three prisoners. As the prisoners leave the jail, one of them shouts, "Here comes Billy [Soule]!" and they make their getaway. Despite a search until long after dark by law enforcement officers, including Sheriff John Behan, Chief of Police Virgil Earp, Morgan Earp, and Wyatt Earp, no trace of the escapees was found.

10/26/1881^E - Shooting at the O.K. Corral takes place. During the subsequent hearing before

Judge Wells Spicer, William H. Soule declares in testimony related to Frank McLowry [sic] and Billy Clanton that his occupation is "jailer and deputy sheriff of Cochise County."

12/25/1881^{B2} - William Soule takes part in "Cuddy's Convention" which creates the People's Independent Ticket with a platform requiring "[t]hat our nominees pledge themselves to ...spare no efforts in securing peace and freedom from the lawlessness which has heretofore reigned in our midst." This appears to be a joke as the ticket is not ratified and the "convention" adjourns with a general laugh.

6/10/1882^{B3} - Hiram Potter, a jail inmate, uses a shaving razor to cut another inmate who is being locked up and escapes onto the street where jailer Soule's shotgun misses fire twice. Substituting a rifle, Soule continues pursuit and holds Potter at bay until another deputy "stole up and dealt [Potter] a well-directed blow with a stick on the head...."

1883^{C1} - William Henry Soule [is married] to Jenny Bell Golton [Goldstein?, Goldston?], 6 June 1883 at Tombstone by David McFawn, Methodist Min. Wit: Mr. and Mrs. E. H. Dean. Rec: p 46.

12/19/1891^{B4} - "Billy" Soule, now living in Los Angeles, sells a saloon business there for \$1,500.

3/19/1894^{B5} - As announced in the *Yuma Sentinel*, Mrs. Wm. Soule arrives in Yuma [AZ] with her son and daughter from Los Angeles to make it her future home. William, the former well-known deputy sheriff of Cochise Co., and his family will occupy one of the Modesti Cottages on First St.

1910^{A2} - William (age 64) & Jennie Soule (age 42); children Marie L. Miller, William, Jennie B., Mona M.; son-in-law Owen Miller; grandchild Albert Miller enumerated in Los Angeles, Los Angeles Co., CA.

1910^{A3} - William (age 62), inmate, enumerated in the Pacific Branch, National Home for Disabled Volunteer Soldiers (Sawtelle Veterans Home), Malibu Township, Los Angeles Co., CA.

6/30/1916^{A4, 5} - William H. Soule dies two months after being dropped from the rolls of the Sawtelle Veterans Home in Los Angeles County, CA. He is buried in the Los Angeles National Cemetery.

The information about William H. "Billy" Soule I was able to uncover shows that he truly was a part of the history of the West. He served as a bugler in Co. A, 2nd Cavalry Regiment California, enlisting in Sacramento in 1864 and serving on the side of the Union. Sacramento was the western end of

the Pony Express and a terminus of the First Transcontinental Railroad which began construction in 1863. After his discharge, he was in Bisbee, AZ, a mining town founded in 1880 and located not far from the Village of Tombstone, another mining town which had been founded a year earlier in 1879. He played a tangential part in the 1881 O.K. corral shootout and testified at the subsequent hearing.

Is William H. Soule, jailer and deputy sheriff of Cochise County, AZ, a direct descendant of George Soule? Alas, despite a relatively extensive, although, admittedly, not exhaustive, amount of online research, I was unable to discover the parents of William H. Soule, born 1844-1848 in MA. [Note: I had to cut short my research or the newsletter would still be in my computer and not in your hands!]

Online resources are now astonishingly numerous and easily accessible; however, you can't find everything you want to know online, nor can you put your complete trust in what you do find [see *Internet Helps, Hurts Researchers* article on pg. 8]. There is still a need for old-fashioned on-site

research, letter writing, phone calling, and sharing cousin-to-cousin. Maybe you are related to William H. Soule. Maybe you have an interest in solving a good genealogy mystery. The "Gunfight at the O.K. Corral" has, since the day it happened, been controversial. The book, <u>The Earp Brothers of Tombstone: The Story of Mrs. Virgil Earp</u> by Frank Waters, which contained the exerpt sent by Mr. Ross and shown above (pg. 3) was considered for years after its publication in 1961 to be an authoritative book on the subject. Interestingly, however, in more recent years, Mr. Waters and other Tombstone/Earp/O.K. Corral authors have become the center of their own controversies. 

He may very well have viewed the gunfight as nothing more than "business as usual."

Internet Helps, Hurts Researchers

ith the advent of the Internet, we all began to see the vast amount of genealogical information that began to appear in cyberspace. Those of us who have been using the Internet for the last decade for research have been amazed at the increase in the amount of information that becomes available with each passing day.

There are several types of information available online. The first consists of family tree data submitted by individuals who have researched their own family trees.

These may appear on any number of websites, from a personal web page of the researcher to large databases such as Family Search or Ancestry.com. Sometimes these sites are passworded or privatized so that the only persons who can view them are those



that the researcher has chosen. In other cases the data is open for anyone and everyone to view.

Caution is advised on these sites. Unless the data is documented completely, the information cannot be accepted as true. These sites are great "jumping off" places, where researchers can locate information that might not otherwise have been obtained, but that information needs to be checked against primary sources for accuracy. All too often erroneous information is placed on a website and takes on a life of its own, being propagated by others who take it as fact and pass it on to others, who in turn pass it on, so that the misinformation is soon taken as fact by many others. At this point it becomes very difficult to correct such an error. The best way to avoid being embarrassed by placing erroneous data in one's family tree is to make certain to check all sources and search for documentation of every fact stated. This may seem like a laborious undertaking, but what good is the information if it proves to be false?

Another type of information is online databases. These may consist of indexes, actual images of documents, or both. Needless to say, this type of information is invaluable to the researcher. The indexes can be used to locate documents and order copies of them if the images are not available online. When the actual images are supplied, the information becomes even more valuable, saving the researcher time and money.

Most all researchers are aware of the subscription data bases, and more are coming aboard every day. One has to decide which, if any, he will subscribe to. Most offer a free trial of a week or two or even a month so the researcher can determine if the database will be of use to him.

The Family Search site, commonly referred to as "the Mormon site" or "the LDS site" is an example of a free data base. Family Search has recently "opened the granite mountain" in Salt Lake City and the goal is to make the billions of records on microfilm stored there available to researchers online. This, of course, will be taking place over a period of several years as the amount of information in their holdings is beyond comprehension!

Many libraries, including almost all in western NC, offer "Heritage Quest" to persons holding a



library card. This can be accessed conveniently from one's home computer and includes such research essentials as the US Census. Most years are indexed,

but even those which aren't can be browsed, much as the "old fashioned" way of scrolling through microfilm. Several libraries also offer the library version of Ancestry.com, but one must visit the library to use this service. It is offered to patrons at no charge, however.

2010 Soule Kindred Annual Report

Article IX, Section B of the Bylaws requires the President to issue to the membership an annual report with a summary of accomplishments and business conducted during the previous year. The 2010 Financial Report Summaries can be found on page 14.

The Board year began on October 15, 2009. Officers were Marcy Kelly Brubaker and Karen L. McNally, Co-Presidents; Rosemary Soulé Peters, Vice President; Christine Schlosser, Secretary; and B. J. Haner, Treasurer. Board members included Judith C. Hill; Mary Soule Kelly; Norman Soulé; Susan Fogg Eisdorfer; Kathy Strauss; Marjorie Everoski; David Hargreave; Margaret "Peg" Rocke; and Past President, Christine Hill.

The Co-Presidents held a Board meeting via conference call on October 31. This was the first of many "firsts" for the Board and the organization. Throughout the year the Board conducted business via conference calls, e-mail, and, of course, at the Annual Reunion (which, itself, was the first-ever reunion held on a cruise ship). This high level of contact allowed the Board to accomplish much more than would, otherwise, have been possible. A list of those accomplishments was published in the October 2010 Soule Kindred Newsletter. A few are highlighted here.

Probably the most significant accomplishment was the change in the Board of Directors election process. In the summer of 2010, for the first time, *all* members were given the opportunity to make nominations to the Board [see page 9 for information on this year's nomination process] and to vote on the final slate of candidates. Forty percent of Soule Kindred members voted last year to elect Anna Bristol, Helen Soulé, and Andrew Turner to the Board.

The Soule Kindred archives were moved to a new, climate-controlled home at the Drew Archival Library in Duxbury, MA. And home they truly are because George was one of the founders of Duxbury, owned significant property there at Powder Point, and is buried in the Standish Cemetery. A headstone for George was placed in the cemetery by Soule Kindred in 1971.

Phase I of the website upgrade was completed in July 2010. The website was redesigned and expanded with the addition of more content. Also, for the first time, membership dues and donations could be paid online.

The first Soule Kindred Membership Directory was created and mailed to all members. The directory contains not only the names and addresses of those who wished to be included, but also lists each member's lineage back to George. This is a great resource for all members.

The Soule Family Tree Project (SFTP) Committee was formed. Composed of volunteer genealogists, the committee's purpose is to help members identify their lineage. The SFTP Committee reached out to 152 members whose lineage did not appear in our very first directory. By the end of 2010, the committee reported that Soule Kindred now had on file the lineages of 85% of our members. Additionally, through the committee's efforts, invalid addresses and the names of deceased members (Soule Kindred had not been notified of their deaths) were removed from the membership list.

It was an extremely busy and productive year. That so much was accomplished in a single year is a testament to the dedication of the Board Members, who, of course, are all volunteers, and their commitment to ensuring the sustainability and future growth of Soule Kindred.
